How are lead and paint connected?

Lead used to be a common ingredient in paint that was used in homes and on children's toys. When paint made with lead chips, it releases lead into the surrounding environment. It is no longer legal to put lead in paint.⁵

Does my home have lead paint?

Today, lead paint might still be in homes that were painted before 1978. Sometimes lead paint is hidden under layers of new paint.⁵ Landlords are required to share information about any use of lead paint on their property to renters.⁶

How do I prevent exposure from lead paint?

If you think you live in a home built before 1978, you can take these steps.

- Remove any paint chips and clean areas with peeling paint weekly.⁵
- Test and treat any possible lead in your home

Who is most at risk and how are they affected?

There is no safe level of lead in the blood.¹



- Children under 6 years are more vulnerable to lead exposure because of their tendency to explore the world by putting things in their mouth.¹
- Women exposed to lead during or before pregnancy can have higher risk of miscarriage, stillbirth, and premature birth.¹

How can I protect myself and my community from lead in paint?

Painting over lead paint does not adequately protect you from lead exposure.
